2. We have estimated the cost of the completion to obtain Occupation Certificate/ Completion Certificate, of the Civil, MEP and Allied works, of the Building(s) of the project. Our estimated cost calculations are based on the Drawings / plans made available to us for the project under reference by the Developer and Consultants and the Schedule of items and quantity for the entire work as calculated by **M/s IM Cost Management Pvt. Ltd** as a quantity Surveyor appointed by Developer, and the assumption of the cost of material, labour and other inputs made by developer, and the site inspection carried out by us.

3. We estimate Total Estimated Construction Cost of completion of the building(s) of the aforesaid project under reference as **Rs. 2,63,63,74,483**. (Construction cost includes, cost incurred on construction and development of project including, on-site expenditure for development of entire project, i.e, salaries, consultant fees, site overheads, cost of services (including water, electricity, sewerage), cost of machineries and equipment including its hire and maintenance costs, consumables, development manager fees, finance cost incurred on borrowings for development / construction cost, payment of taxes, cess, fees, charges,

premiums, interest etc to any statutory authority etc.), The estimated Total Cost of project is with reference to the Civil, MEP and allied works required to be completed for the purpose of obtaining occupation certificate / completion certificate for the building(s) from the **Town & Country Planning, Haryana** being the Planning Authority under whose jurisdiction the aforesaid project is being implemented.

4. The Estimated Cost Incurred till 30-Jun-2017 is calculated at **Rs. 1,58,21,79,547**. The amount of Cost Incurred is calculated on the base of actual expenses done for Construction of said project as on 30-Jun-2017.
5. The Balance cost of Completion of the Civil, MEP and Allied works of the Building(s) of the subject project to obtain Occupation Certificate / Completion Certificate from **Town & Country Planning, Haryana** is estimated at **Rs.1,05,41,94,936**.
